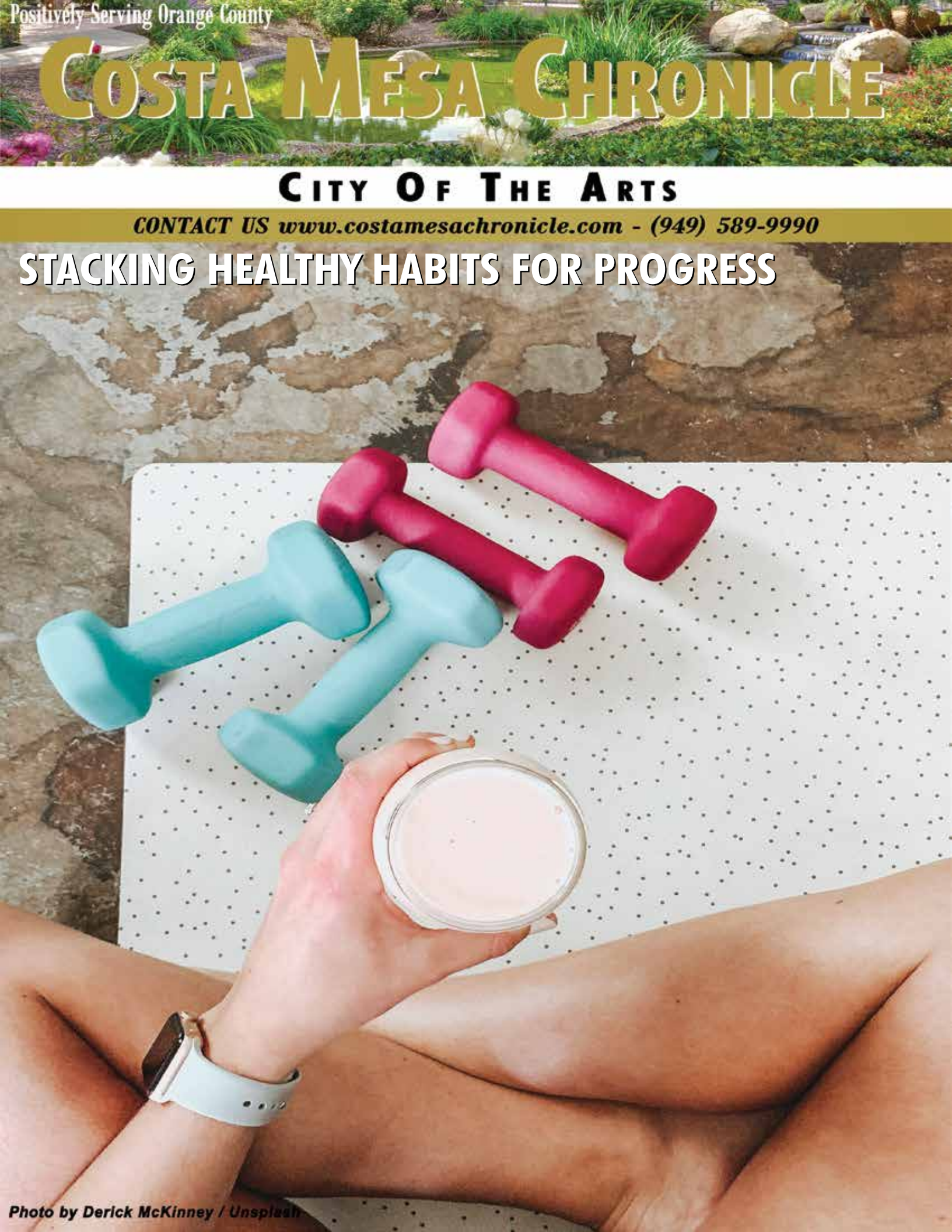

WORM SCIENCE, RUG HOOKING, GARDEN FERMENTATION & BROADWAY: CASA ROMANTICA UNVEILS A JAM-PACKED SPRING 2026 SEASON

This spring, Casa Romantica Cultural Center and Gardens, Southern California's premier museum destination for arts and culture, invites the community to dig in, get creative, and connect through a dynamic lineup of hands-on workshops, family-friendly programs, live performances, and wellness classes. With offerings spanning composting and fermentation to ballet, Broadway, and youth art intensives, Casa Romantica's Spring 2026 calendar is brimming with opportunities to learn, create, and celebrate together.

Kicking off the season, Casa Kids: Worm Science (Feb. 21 at 10:30 a.m.) offers children ages 5+ a hands-on introduction to composting. Young gardeners will explore worms and microorganisms at work, learn how food scraps transform into nutrient-rich soil, and take home simple tips to start composting at home. Admission is \$8, with members and children 12 and under free.

A major highlight of the season is the Casa Kids: 6-Week Art Class Series (Ages 11-14) led by artist Kelly Gallaher. Meeting select Saturdays from March 7 through June 6, this inspiring series encourages imagination, technique, and self-expression in Casa's downstairs classroom. Students will experiment with various materials and styles while building skills in a supportive, engaging environment. The \$75 registration fee (\$60 for qualifying member levels)

includes all materials for the full six-week session.

Adding to the season's creative energy, Casa is excited to debut: The Greenhouse, a rotating floral exhibition transforming The Studio into a living gallery from March 23 through April 12. Opening the series, Adrienne Moore + The Bloom of Time: Flowers as Medium: Expressions of Human Emotion elevates floristry into fine art. Artist-turned-florist Adrienne Moore uses fresh flowers and acrylic paint to connect with the emotions embedded in each sentiment, engaging with flowers as carriers charged with meaning, memory, and shared human ritual. Visitors should leave the exhibition feeling inspired and more deeply connected to flowers, floristry, and humanity.

Garden lovers can explore preservation traditions at Garden Spotlight: Fermentation and Preservation (March 11 at 6 p.m.), where master canner and garden club member Nina Ostensen will lead an informational slideshow and tasting in Casa's Main Salon. Guests will sample homemade preserves and take home a booklet of recipes and tips. Space is limited to 25 participants.

On March 13, Casa Romantica will host its standout spring fundraiser, David Burnham's Broadway, an elegant evening featuring a seated three-course dinner, pre-show reception, and a live performance by acclaimed vocalist David Burnham singing favorites from Chicago, Wicked, Phantom of the Opera,

and more. The evening begins at 5:30 p.m., with tickets at \$225, and includes an opportunity drawing for luxury prizes.

Additional spring programming continues the momentum with Free Family Sundays: Chamber Music Day on March 1, offering complimentary admission alongside youth chamber music performances and music-themed crafts for children. Experience the Casa Kids Concert: N8tive Hoop on March 21 at 10:30 a.m., where World Champion Dancer Terry Goedel brings Native American culture to life through vibrant hoop dance, storytelling, and interactive songs. The Rug Hooking Workshop: Geranium in Terracotta Pot on March 29 offers a restorative textile art experience where participants create a 6"x6" piece using traditional wool and burlap techniques with all materials provided; and Sip and Paint: Vessel (21+) on March 18 at 6 p.m., is an intimate art-and-wine evening led by local artist Kelly Gallaher, offering step-by-step instruction in a relaxed, social setting.

Ongoing weekly offerings include Ballet (Mondays), Meditation with Jim Noggle (Tuesdays), Yoga in partnership with YNG Studios (Wednesdays), weekly Story Time for families, and "Ask a Master Gardener" sessions with UC Master Gardener volunteers on the first and third Sundays of each month.

From soil to stage, Casa Romantica's spring season reflects its mission to cultivate art, nature, and community

OC CLERK-RECORDER HUGH NGUYEN TO CELEBRATE 10 YEARS OF SPECIAL SATURDAY PASSPORT DAYS ON MARCH 28

Orange County Clerk-Recorder Hugh Nguyen invites families and individuals to get a head start on travel plans at the 10th Special Passport Day on Saturday, March 28, 2026, from 9:00 a.m. to 3:00 p.m. at the Old Orange County Courthouse (211 W. Santa Ana Blvd., Santa Ana, CA 92701), where residents can apply for a new U.S. passport and have passport photos taken onsite in one convenient stop.

The milestone event marks a decade of Special Passport Day service in Orange County as demand for passport services continues to grow. In 2025, the Clerk-Recorder's Office accepted 20,197 passport applications, a nearly 30 percent increase over 2024, and took 15,766 passport photos, up more than 38 percent from the year prior. Staff have also heard from families applying for passport cards as a convenient form of identification for their children.

The Saturday timing is especially helpful for families, since both parents are required to be present when applying for a passport for children under age 16. For applicants ages 16 and 17, only one parent needs to be present.

"Special Saturday Passport Day is one of the ways we've helped families take care of passport needs without missing school or work," said Clerk-Recorder Nguyen. "As travel continues to rebound and major global sporting events approach in 2026, we encourage residents to plan ahead and avoid last-minute stress."

Due to high demand, appointments are highly recommended. Walk-ins are accepted on a first-come, first-served basis. 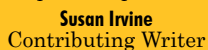

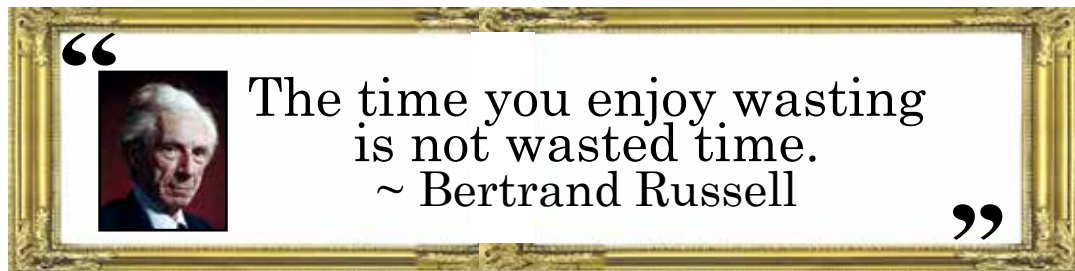
Manage Stress

One-Pot Creamy Shrimp Scampi

Prep time: 5 minutes
Cook time: 25 minutes
Servings: 4

- 1 package (12 ounces) SeaPak Shrimp Scampi
- 1 1/4 cups half-and-half or milk

- 1 1/4 cups chicken stock
- 8 ounces linguine noodles
- 6 cups fresh spinach
- 1/4 cup grated Parmesan cheese
- 4 lemon wedges

In large, high-sided saute pan, add shrimp and cook according to package directions. Remove shrimp to bowl and keep warm.

In same pan with scampi sauce, stir in half-and-half and stock. Bring to low boil. Add pasta. Cook, stirring occasionally, until pasta is cooked al dente, 8-10 minutes.

Stir in spinach and cook just until beginning to wilt. Stir reserved shrimp into pan.

To serve, divide shrimp scampi between four bowls and top each with grated Parmesan. Serve with lemon wedges.

Butterfly Shrimp Bruschetta

Prep time: 15 minutes
Cook time: 15 minutes
Servings: 6

- 1 package (9 ounces) SeaPak Jumbo Butterfly Shrimp
- 1 baguette
- 3 garlic cloves, divided
- 6 tablespoons olive oil, divided
- 3 cups grape or cherry tomatoes, seeded and finely diced
- 1/3 cup chopped basil, plus additional for garnish

salt, to taste
pepper, to taste
Preheat oven to 425 F. Bake shrimp according to package directions and keep warm.

Slice baguette to match number of shrimp. Rub one garlic clove over one side of each slice of bread. Brush garlic-rubbed sides with 3 tablespoons olive oil. Set aside.

Finely dice remaining garlic. In medium mixing bowl, stir tomatoes, remaining olive oil, diced garlic and 1/3 cup chopped basil. Season with salt and pepper, to taste, and set aside.

In large, hot skillet, working in batches, add baguette slices oil sides down and cook until browned around edges. Remove from pan.

Top each baguette slice with small spoonful of tomato mixture and one shrimp. Garnish with basil leaf. (Feature Impact)



NEWPORT BEACH HISTORICAL SOCIETY BRINGS LOCAL STORIES TO THE BIG SCREEN

The community's rich past took center stage at a pair of captivating film events in February as the Newport Beach Historical Society hosted documentary screenings that drew history buffs, film fans and longtime residents alike to celebrate Southern California's vibrant cultural heritage. Historical Society

Rediscovering the Origins of Irvine and Newport

On Wednesday, February 4, filmgoers gathered at the historic Lido Theater for a special screening of an Irvine documentary that offered rare insights into the origins of the Irvine Ranch and its transformation into one of Orange County's most influential master-planned communities.

The event, curated by filmmaker Nathan Gopen, showcased previously unseen footage and extended interviews that traced 150 years of history — from sprawling agricultural fields to the modern urban landscape that includes communities like Newport Beach today. Attendees also enjoyed a director-led Q&A session, deepening appreciation for how early ranching and land development helped shape the region's economy and identity. The screening drew significant interest from local historians and residents alike, many of whom shared personal memories of the area's evolution

and discussed the importance of preserving such stories for future generations.

On Thursday, February 26, another sold-out crowd packed the historic Lido Theater for the premiere of "Sin City: Newport Beach," a feature documentary written and directed by local filmmaker Ed Olen. The film dives into Newport Beach's lesser-known era during the 1920s and '30s when the seaside town was a bustling playground of bootlegging, gambling and nightlife — a stark contrast to its contemporary reputation for pristine beaches and luxury living. Drawing from the book Bawdy Balboa by Judge Robert Gardner, the documentary brings to life colorful anecdotes and personalities from Newport's past, including dance halls, speakeasies and even a short-lived brothel that contributed to the city's colorful reputation

Both film events reflect the Newport Beach Historical Society's broader mission to connect the public with local history through engaging programming. From deep dives into Irvine's ranch roots to the rollicking tales of Prohibition-era Newport Beach, these screenings offer residents and visitors alike a window into Orange County's past that is anything but dry. 



Taste of Wine & Food

DORA RISTORANTE BRINGS TRE FORCHETTE DISTINCTION TO LA JOLLA

Chef Accursio Lota and Corinne Gorla, the husband-and-wife team behind North Park's acclaimed Cori Pastificio Trattoria, a Gambero Rosso Tre Forchette awardee, have opened Dora Ristorante in La Jolla's Theatre District. Since its November 20 debut, the restaurant has drawn immediate attention not only for Lota's *résumé*, which includes Barilla's "World Pasta Champion" title and experience in Michelin-starred kitchens, but also for the deeply personal story behind the name.

Named for his grandmother, Dora reflects Lota's upbringing in Menfi along Sicily's southwestern coast. Childhood memories of running through artichoke fields, preserving tomatoes, and preparing freshly caught tuna at his Nonna's table shape a menu grounded in tradition and refined through technique. "So much of my cooking is rooted in the smells and sounds of my Nonna's home," Lota says. "Opening Dora in La Jolla feels like picking up a thread from home."

The 3,800-square-foot space, designed by Bells + Whistles and anchored by a sweeping bar overlooking the open kitchen, channels Southern Italy's coastal warmth through sun-washed tones and artisan tilework.

Chef de Cuisine Luis Esteva, whose background includes Kettner Exchange and Nolita Hall, works alongside Lota in executing the restaurant's coastal Sicilian vision. Behind the bar, Mediterranean botanicals, citrus, and amaro-driven cocktails complement a thoughtful wine list curated by sommelier Federico Cavalleri, highlighting coastal Italian and West Coast producers with an emphasis on indigenous varietals. Guiding the dining room is General Manager Steven Schwob, formerly of Trust Restaurant Group and Marisi.

In January, a Gambero Rosso inspector visited and left impressed. Dora now stands as just the seventh restaurant in the United States to

earn the prestigious Tre Forchette distinction, a remarkable milestone only weeks after opening. The award was announced the day before our visit, and Chef Luis and General Manager Steven Schwob were radiating pride as they shared the news.

Dora's pre-theatre prix fixe menu (\$65) reflects both creativity and efficiency. The current pre-dinner offering, inspired by the La Jolla Playhouse production "The Recipe" by Claudia Shear, an homage to Julia Child, allows guests to select an appetizer, second course, and dolci, with the option to add a curated two-wine flight for \$27. The pacing is intentional, allowing diners to enjoy a complete experience without watching the clock.

We began with Arancini ai Porcini e Tartufo, Carnaroli rice enveloping porcini and mozzarella, finished with a rich black truffle passata. The exterior crackled delicately before yielding to a creamy center. Pillowy focaccia, fermented for 36 hours, arrived alongside a vibrant eggplant caponata studded with olives and tomatoes in extra virgin olive oil. Alici marinate—marinated anchovies with basil and tomato—added briny brightness that was perfect on the warm focaccia.

Frank and I paired these starters with a 2022 Mongrana Super Tuscan from Querciabella, Italy, a Sangiovese-driven blend that balanced red fruit and structure against the earthiness of the truffle and porcini. Guests could also begin with botanical-forward cocktails, draft beers, mocktails, or selections from a well-curated list of Italian and California whites and reds. Polpetta alla Griglia followed—beef and veal meatballs kissed by citrus leaves and served with tomato ammglio rooted in Sicilian tradition. The citrus lifted the richness without overpowering it. Carpaccio di Tonno showcased thick-cut local bigeye tuna slices dressed with tangerine olive oil, arugula, capers, and Fresno chili, where heat and zest framed the purity of the fish.

From there, the kitchen's technical precision became even more apparent. House-made ricotta and spinach ravioli, finished simply in salted butter and sage, delivered clean, focused flavor. Pesce del Giorno—swordfish on this evening—arrived perfectly cooked, flaky and moist, accented with roasted tomatoes, herbs, arugula, radicchio, and a grilled lemon wedge that brightened each bite.

The gnocchi with truffled pork sausage sugo, garnished with pecorino, pesto, and basil, may have been the evening's

standout. Each dumpling was tender yet firm, allowing the sugo to cling generously. Alongside it, Pollo alla Griglia—half Mary's chicken with fennel pollen, chicory, blistered grapes, and roasted squash—offered depth and balance.

Dolci concluded the evening with Cioccolato, Cioccolato, Cioccolato—custard, mousse, and gelato presented as a triple-chocolate crescendo—and a dark chocolate stracciatella gelato with pistachio crumble. A cappuccino sealed

the experience.

Shortly after we were seated, our exceptional server, Ian Driscoll, set the tone with polished, attentive service. Early in the evening, Frank leaned over and simply said, "This is world class." It was easy to agree. Dora delivers Sicilian soul, technical precision, and coastal elegance—an award-winning and well-earned addition to La Jolla's dining scene.
